

## McNeill Online Services Agreement

Welcome! McNeill Hotel Holdings, LLC and its affiliates ("McNeill," "we" or "us") provides services and access to McNeill's Websites, either alone or in conjunction with its affiliates, agents and partners. By accessing or using this Website (the "Website") which is the property of McNeill, you hereby accept and agree to comply with this McNeill Online Services Agreement ("OSA" or "Agreement") which applies to all McNeill's Websites, other electronic channels as described below, and electronic content, services and tools. This includes any current features or content or those that we may add in the future. We refer to all of the above as "McNeill services."
